

Procedures for Obtaining Design Registration

Filing An Application

- Name and address of each creator
- Name and address of each applicant
- The name of article
- Drawings
 - Containing enough views to completely describe the design
 - 6 view drawings, Perspective views (if required) etc.,
- Priority information and certificates, if claimed

Partial Designs

- Protection of Parts of a Design for the Characteristic Parts of an Article
 - "Design" in this law means a shape, pattern or color or any combination thereof in an article (including part of an article) which produces an aesthetic impression on the sense of sight. (Section 2(1))



Related Designs

- Protection System for Designs of Variations
 - Similar designs basically face rejection based on the prior similar designs
 - The system allows registrations of similar designs
 - The system helps to clear the scope of design rights



Related Designs

Requirements

- Related designs must be similar to the principle design
- Applicant must be the same
- Related design applications should be filed before publication of the principle design


Limitation

- Need to grant licenses to the principle design and the related designs
- The related design rights expire 20 years after the registration dates of its principle design rights





Partial Design (Principal Design)








Tips for Designating Japan in Hague Application

- Priority Documents
 - Must be submitted directly to the JPO within 3 months from the International Publication date
 - Should be filed through a Japanese representative
- Six Orthographical Views are Basically Required
- An Intl. Design Reg. with Multiple Designs
 - Automatically divided into multiple applications
 - Applicants need not to file divisional applications at the Japanese national phase



Tips for Designating Japan in Hague Application

- Grace Period
 - Should be requested at the time of filing an international design application





Major Advantages of Obtaining Design Rights in Japan

- Quicker Registration
 - 6 months from filing to first actions
- Higher Percentage of Registration
 - Almost 90%

- Longer Duration of Registered Right
 - 20 years from Registration Dates



Major Advantages of Obtaining Design Rights in Japan

Easier Enforcement

- Discussion based on appearance of products
- Useless technical discussion less likely in litigation
- Greater resistance to invalidation




Functional Shape Can Be Protected by Both Patent Law and Design Law




Functional design which is **not** "**solely** consisting of a shape that is **indispensable** for securing functions of the article"










 Graphic Images that are prerecorded on a device for a specific use like digital camera






Electronic computer with pedometer function








Graphic image displayed by a game machine















Examples of Designs including a Graphic Image on a Screen (Transitional)







US Practice on GUI

GUI Design is protectable as an ornamentation on an article of manufacture; the article of manufacture (e.g., display screen) is shown in broken lines






Conversion of Application from Patent to Design

Basic Precautions

- Strictly limited to the same applicant and the same design.
- When the converted application is filed,
 the original patent application shall be deemed to have been withdrawn unless a divisional is filed prior to the conversion.
- A Paris Convention priority claim is effective in the design application only when the patent application was filed from 6 months from the first application that serves as the basis for the priority right.







Examples of Registered Design That Has Overcome Non-obviousness Rejection at Appeal Stage


Design Law Sec. 3-(2)

Where, prior to the filing of the application for design registration, a person ordinarily skilled in the art of the design would have been able to easily create the design based on shape, patterns or colors, or any combination thereof that were publicly known in Japan or a foreign country, a design registration shall not be granted for such a design (except for designs prescribed in any of the items of the preceding paragraph), notwithstanding the preceding paragraph.




Example of Designs Registered After Appeal 1 JPD1349661 Mobile Terminal Device / Apple








Example of Designs Registered After Appeal 2 JPD1453870 Digital Camera / Sony


